The information and pictures on William Abraham Nixon's family that they shared with me are what make this history possible. Some of the above are no longer living but I will be indebted to them for their generosity of sharing family records.

 $William\ Abraham\ Nixon\ {\rm was\ born\ in\ Dublin,\ Ireland\ and\ immigrated\ to\ Liverpool\ sometime\ before\ 1835.\ We\ do\ not\ know\ if\ he\ was\ born\ in\ the\ city\ of\ Dublin\ or\ the\ county.}$

Hannah Fawcett Nixon, second wife of James William Nixon I, writes in a letter dated August 13, 1923 the following:

"I have just been looking over some letters that Grandfather Nixon sent to [us] after his wife died he speaks of a missionary calling to see him, so this missionary had told him to send us his father's and mother's names so he says that his father's name was John & his mother's names was Washington Nixon... but he don't say what her maiden [name] was, your fathers mother's name was Bridget Degnan... Hannah quotes from the letter again, I was 76 year's old on the 24th of March. I was born in 1816." [See Appendix for complete letter.] His death certificate gives his father as William and mother as Iane

William married Bridget Dagnal in Liverpool, 2 Mar 1835. He is married under the name of Abraham Nixon. Bridget was born about 1804 in Longford, Ireland. We do not know if she was born in the city of Longford or the county. James, her son, states her name was Degnan. Matilda Nixon Gregory's death certificate also give her name as Degnan but the marriage record and birth records of Anne and Edward, Bridget's children, give her name as Dagnal.

A letter to Ernest Whitehead from Mary Louise Nixon, dated March 10, 1936 gives some interesting insights to William's family. [Letter edited to facilitate reading.]

Crossville, Tenn March 10, 1936 Mr. & Mrs. E. L. Whitehead Dear Cousins,

I have so few cousins am glad to have you and your wife added to my list, have only two living, Mrs. Harvey William now living in Seattle, Washington & one in Los Angeles, Cal.

William Nixon [This is Mary's half brother.] of Farmington, Minn, his wife was from Anoka Minnesota, her name, Miss Delia Lane. I had a letter from my sister Mrs. Agnes Elizabeth Rathbun & she said she had a letter from you and seemed much pleased and wrote to me of our family record of our births. I answered right away & presume you have received it by this time. I know nothing of the birth dates of my half sisters. Jennie was 20 years old when she was married, if she was married in 1869, Dec 7, that would make her, 87 years old., If she was now living, I think she was the youngest of that family. Of fathers first wife I could tell you nothing.

I know very little of father's folks. His father was a piano maker. I think he owned his factory. His mother played the piano & a harp. Father was a very stern man in his family & we children dare not question him but I know from the little he would say they were very fine people.

He had a brother James, the oldest, two other brothers, were killed in the war between England & India, The Crimean War. They were musicians in the band. His father died when he was about, I think 12 years old & he married when he was 19 years old and came to America in the late 40s. They were two months on the way across on account of a ------ weather.

Father was a very successful business man. He had a general store at St. Cloud & made money & through mother's thrift and their saving had quite a bit of property when he died. How old was James Nixon when he died, my brother? My sister Agnes could tell you something maybe of the half sisters, if they are living, for she has seen them since I went from home. They all received a share in the estate when father & mother died.

And you are only 30 years old & how young that seems to me and I hope you have many happy days. We have had a very cold winter for Tennessee, the coldest in 30 years, went to 10 degrees below zero and Agnes writes it had been 40 below in Minnesota. My brother Harry is here for the winter but intends to go back to Dakota this summer.

Anything else I could help you in your write up of the Nixon family I will be glad to help you. It will be very interesting to me & all of our family. Harry & my husband send kind greetings to you & your wife. I would be glad if you could correspond to my son William. He is young & he would enjoy hearing from you, a cousin.

The vital records of Wales show William and Bridget had two additional children, Edward and Anne, James William Nixon, William and Bridget's first child, did not name these children in his autobiography. A death certificate for Edward was located but Anne's has not been found. Edward was born 28 February 1840, while the family was living on Merthyr Street, Caernarvon, in the county of Caernarvon and died 8 Aug 1840. Apparently between February and August of 1840 the family moved to Tanrallt Street. William's vocation, as shown on the birth and death certificates was a labourer, a hawker, and a turner. Anne was born 27 Sep 1841. The 1841 census for Wales shows Abraham Nixon and Bridget living on Tanrallt Street.

James William Nixon I, states in his autobiography that the family moved from Liverpool to Bangor, Wales. It is very possible that the family moved to Bangor after 1841. No evidence is found of William and Bridget living in Bangor other than the statement of James, their son.





It appears that Bridget may have immigrated to America in 1850. William Abraham Nixon first came to New York, then Cleveland, Ohio and finally settled in Minnesota. The divorce papers state:

The complaint for William A. Nixon's divorce from Bridget Degnan/Dagnal Nixon states the following: William Nixon

Vs

Bridget Nixon

Territory of Minn county of Ramsey, First Judicial District

To the Honorable District court in and for the county of Ramsey, Territory of Minnesota.

The complaint of William Nixon, plaintiff in this action respectfully shows to the court that he is thirty-seven years of age and was married to Bridget Nixon, the defendant in this action, in the year A.D. 1834 in Liverpool, England-that the said defendant is now forty-nine years of age, and a resident of this county and Territory-that in the year A.D. 1848 the said plaintiff and defendant removed from England to the United States of America, with their family. That there are 5 children of the said plaintiff & defendant now living, the oldest being 18 years of age, and the youngest four years of age-that for more than a year last past, to wit since the 10th day of June A.D. 1852, the said plaintiff has resided in the said county of Ramsey, Territory of Minnesota. This plaintiff further complains and alleges that since Bridget Nixon his wife, is now, and has for 3 years immediately preceding the filing of this complaint, been a habitual drunkard. Wherefore the said plaintiff asks the court to adjudge and decree a divorce and separation from said nuptial ties, or bonds of matrimony, heretofore uniting this plaintiff and with the said Bridget Nixon and also that the care custody & maintenance of since minor children shall be entrusted to the plaintiff.

Being sworn, says he is the plaintiff mentioned in the foregoing complaint and the same is true of his own knowledge, except as those therein stated on his information or belief and so to those matter he believes it to be true.

Sworn ascribed to before me this 12th Day of December A. D. 1853 Signed William Nixon

A Bridget Nixon age 45 along with children John age 12, Matilda age 8 and Marie age 2 immigrate to America in 1850 on the ship *The New World*. John may be Catherine. The ages fit to be Bridget and her three daughters. There are several questions concerning this entry. Why is one of the children named John who would correspond to Catherine's age and when did William, James William and Billy immigrate? Is it possible that Bridget returned to England or Wales after the family immigrated and she then returned in 1850? (See Appendix)

We do not know what William's profession was before moving to St. Paul. From his divorce record dated December, 1853, in Ramsey County, Minnesota, he states he first came to the United States in 1848, first to New York, then Cleveland and St. Paul in 1852. We do not know what his profession was before moving to St. Paul, but it was probably a merchant. The 1841 census of Caernarvon gives his profession as a turner. The birth and death records of Edward and Anne Nixon show his vocation as a laborer, a hawker and a nutseller.

In the book "Pen Pictures of St. Paul Minnesota" by T. M. Newson, Published in 1886, the following account is giving of William Nixon:


"WILLIAM NIXON - On Bridge Square, before there was any bridge, was a peanut and apple stand presided over by William Nixon. He did well in his business and finally opened a large hardware store on West Third street. He was an industrious, money-making man, who must have come here in 1854-5. Domestic trouble induced him to leave the city and settle in St. Cloud, where he ran a large store for several years, and then sold out and removed to a farm below ST. PAUL, but is now back again in St. Cloud. He was an Irishman by birth and had the faculty of making money better than any man I ever met. Like many other old settlers of over a quarter of a century ago, he is now stepping down the ladder of life, not unmindful of the fact that the world does move."

St. Paul was a fledgling frontier town in 1852. The influence of the Temperance Society had reached Minnesota and the legislature was induced to pass a stringent prohibitory law; however such repressive measures failed to meet the hope for results. The provisions of the act passed made it a penal offence to manufacture, sell or have in possession, any description of alcoholic liquor, and all liquor found in the territory, was to be confiscated and destroyed. Liquor dealers were not permitted to set as jurymen.

In 1852 Governor Ramsey's annual message told of the progress he had witnessed since coming to Minnesota.

"It is now a little over three years and six months since it was my happiness to first land upon the soil of Minnesota. Not far from where we now are, a dozen frame houses, not all completed, and some eight or ten small log buildings, with bark roofs, constituted the capital of the new territory, over whose destiny I had been commissioned to preside. * * * * Since that day how impetuously have events crowded time! The fabled magic of the eastern tale that renewed a palace in a single night, only can parallel the reality of growth and progress. In forty-one months the few bark roofed huts have been transformed into a city of thousands, in which commerce rears its spacious warehouses, religion its spired temples, a broad capitol its swelling dome, and luxury and comfort, numerous ornamented and substantial abodes and where nearly every avocation of life presents it appropriate follower of representative."


William Abraham Nixon and his family stepped out of the European culture about the year eighteen forty-eight or eighteen forty-nine and began life in the prosperous and growing city of St. Paul in 1852. However, Bridget had a serious drinking problem that led to the divorce. As the biography states, domestic troubles caused him to leave the city of St. Paul and move to St. Cloud. William married Mary Elizabeth Perine after his divorce. Bridget he remained in St. Paul, and continued to have problems with the authorities. She died in St. Paul in 1893.



Matilda Nixon Gregory lived in Iowa and later moved to California. Jennie Nixon Cavender moved to the State of Washington and died there.

William and Elizabeth's children scattered about the same way his first family did. Agnes Nixon Rathbun married Clarence Addison Rathbun and remained in Minnesota. Mary Louise Nixon Johnson married William Johnson and they moved to Crossville, Tennessee. Clarence and Frederick Hamilton Nixon lived in Minnsota. Frederick died in 1914. Fraederick's wife married Richard Davis. She and her husband and her children Frederick and Dorothy moved to Seattle, Washtington. Harry moved to Montana and died there Harry never married.

Ree Howell, inherited several beautiful figuines and dishes from her a great-granddaughter Jennie Nixon Cavender, She was told that William Abraham Nixon made trips to Europe where he purchased merchandise for his store. These advertisements were found in the 1856 St. Paul City Directory.

After the St. Paul store burned about 1856, James William Nixon moved west, married and lived in Utah. Billy Nixon, remained in Minnesota and opened up a merchantile store in Farmington, Minnesota. Catherine Nixon, married 1. Edward Huff and 2. Isaac Stuart. She moved to Illinois and died in Chicago.

The three girls are from a tin type found in possession of one of Agnes Nixon Rathbun's descendants. The resemblance of Jennie to the little girl on the right is very pronounced. The age difference between Jennie and Matilda is five years and there is ten years between Jennie and Catherine. The little girl on the right could be Jennie. Jennie was born 25 May 1848. She appears to be about six or seven years of age in the picture. The picture was probably taken about 1852 or 1853. Jennie was raised by William A. Nixon's second wife, Mary Elizbeth Perine. Matilda was born 15 April 1843. She would have been about ten years old. The other two children are unknown. Edward and Ann died young.



Letter from Mary Louise Nixon Johnson to Ernest Whitehead dated March 1st, 1936 Crossville, Tennessee

Mr. & Mrs. E. L. Whitehead

Dear Cousins

I have so few cousins and glad to have you and your wife added to my list. Have only two living, Mrs. Harvey William now living in Seattle, Washington and one in Los Angeles, Cal. William Nixon of Farmington Minn, his wife was from Anoka, Minnesota. Her name Miss Delia Lane.

I had a letter from my sister, Mrs. Agnes Elizabeth Rathbun, & said she had a letter from you and seemed much pleased and wrote to me for our family record of our Births, Mother & Fathers & their marriage. I have the Nixon Family Bible. I answered right away & presume you have received it by this time. I know nothing of the (p.2) Birth dates of my half sisters. Jennie was 20 years old when she was married. If she was married in 1869 Dec. 7, that would make her 87 years old if she was now living. I think she was the youngest of that family. Of father's first wife, I could tell you nothing.

I know very little of father's folks. His father was a piano maker. I think he owned his factory. His mother played the piano & a harp. Father was a very stern man in his family & us children dare not question him but I know from the little he would say they were very fine people. He had a brother James, the oldest. Two other brothers, were killed in the war between England & Indian, The Crimean War. They were (p. 3) musicians in the band. His father died when he was about, I think, 12 years old and he married when he was 19 years old, and came to America in the late 40s. They were two months on the way across on account of a ----- weather.

Father was a very successful &business man. He had a general store at St. Cloud & made money & through mother's thrift and their saving, had quite a bit of property when he died. How old was James Nixon when he died, my brother?

My sister Agnes could tell you something maybe of the half sisters. If they are living for she has seen them since I went from home. They all received a share in the estate when father & mother died. (page 4)And you are only 30 years old & how young that seems to me. And I hope you have many happy days. We have had a very cold winter for Tennessee, the coldest in 80 years. (It)went to 10 degrees below zero, and Agnes writes it has been 40 below in Minnesota.

My brother Harry is here for the winter and intends to go back to Dakota this summer. Anything else I could help you in your write up of the Nixon family I will be glad to help you. It will be very interesting to me & all of our family.

Harry & my husband send kind greetings to you & your wife. I would be glad if you could correspond to my son William. He is young & he would enjoy hearing from you a cousin way out west.

Dear Emma I received your letter yesterday was glad to hear from you but surprised to hear that you was in the city I thought that you was going to stay at Provo untill the temple opened, I am glad that you got to talk to Will about the temple work, I was Just thinking about the paper tht I sent to you, that your father done for, there were his 2 Grand fathers & two great Grandfathers, so of course where there is a grand father there is a grandmother & so on, so you could do the work for them & have them sealed to their husbands, there would be four women relatives for you & its posible that there are some books in the Genealoical library with your family names in that you could get by paying the researchers a little for their trouble, I have Just been looking over some letters that Grandfather Nixon sent to after his wife died he speaks of a missionary calling to see him, so this missionary had told him to send us his fathers & mothers names so he says that his fathers name was John & his mothers name was Washington Nixon so you see you have got one name to do for but he don't say what her maiden was, your fathers mothers name was Bridget Degnan, in one of the letters that Grandpa wrote to me, he said I will tell you some of my troubles, I willed all of my property to my wife several years ago, & it went along for years the family grew up & two years ago she got very sick with Tumer in her stomach the Dr. said there was no help for her, she must die, then her children persuaded her to make her will, she did so, not telling me anything about it, untill the will was read after her funeral, it willed all of my property away from me to go to her children. I had several Thousand, Thousand dollars in notes & Mortgages that I had loaned to different people & was making a comfortable living from the interest & saving the principle, as I am a very saving man. I am troubled in my mind to think my wife & children had deceived me all of them years till she died, but I cannot blame her, as they persuaded her when she thought she was going to die, it was done so that the first family would get nothing & the last get it all, they are taking all of the furniture out of the house except one bedroom that I occupy, I have a lifes lease of the house, I am geting a family

into the house that will board me for the rent 20 dollars a month, I have a nice little home on the banks of Missippi River only two blocks from the main street & Post Office, I see by the papers that the temple in Salt Lake City was Dedicated I would like to be there & see it, stand fast to your religion, I think more of it than I ever did, I wish I was there to enjoy it, but I am far away & all alone, I was 76 years old on the 24th of March. I was born in 1816. I have some property left that happened to be in my name that I will make use of while I live, then when I am gone you & my first family shall have it, Now you see that our family didn't get all of his estate as she says, now in the first place he willed one thousand to me & five hundred to Mary, as he promised me that he would remember me in his will, before he left Trumbul, well when I got that letter telling me about his will, I wrote & told him that I wished that he should divide it with your Mother for I would be ashamed to look her in the face if I got some & she got none, so he told me to tell your Mother to write to him, so she wrote to him & I think that you & Will wrote too, well then he had his will changed & he had willed your Mother one thousand & me one thousand & you one thousand & Will three thousand & Mary 500- well afterwards there was something said about George not geting any, so he said he didn't want to change his will again so he said that Will could give one thousand out of his, then there was somthing said about Delia being left a widow & poor, so this is what he says about it that he didn't want to change his will any more for they already was trying to make out that he was insane, so he had it arainged like this

We the undersinged heirs of the estate of Wm A Nixon in complience with a wish hereby

expressed by him, that we give a certain amount of the means when received by us from the aboved named estate, do hereby covenent & agree with each other & with said Wm A Nixon that we will each of us pay over to the following named person Mrs. Delia Hutchinson the amounts placed opposite our names

Be it understood that it is my will that J. W. Nixon should pay the sum of one hundred dollars.

Johannah M Nixon pay fifty dollars, Mrs. Emma Mathis pay fifty dollars, Mr. George A. Nixon pay fifty dollars Mrs. Hannah F. Nixon pay fifty dollars, and Mary Nixon twenty five dollars.

This is in accordance with my request this 1– day of Oct A. D. 1894. Wm A Nixon, well time went on & his means was being used up for his expences so that when he died there was very little left for us, so when the court expences were paid we got Just about one half of what he willed to us, so that shows wether our family got all of her grandpa estate or not, I am sorry for Aunt Matilda but I don't see how I can help her, I havnt much of any thing but my little home & that was from my father & nothing to do with the Nixon estate, well Dear Emma I hope tht you & yours are well, Jennie is still here with me yet she is geting better but is very weak yet Charl thought that she had better stay here another week to get a little stronger before she goes back to Enterprise,
